



TRIUMPH MOTORCYCLE DISTRIBUTOR'S LIMITED WARRANTY
(From Engine No. AP 80779)
180 Days or 6,000 Miles

THIS WARRANTY is limited to Triumph Motorcycles distributed by Triumph Motorcycles America Inc., 177 West Orange-thorpe Avenue, Placentia, CA 92670, and sold by Triumph Motorcycles America or its authorized Triumph Motorcycle dealers in the United States or Puerto Rico, and is applicable only to Triumph Motorcycles which have been set up and serviced by an authorized Triumph dealer prior to delivery.

This warranty is given to the first retail purchaser only and is not transferable to subsequent owners.

TRIUMPH MOTORCYCLES AMERICA WARRANTS to the first retail purchaser of the Triumph Motorcycle for which this warranty has been given that if the motorcycle is properly maintained, any part of the motorcycle that is defective in material or factory workmanship under normal use will be repaired or replaced, at the Company's option, without charge during the Warranty Period.

THE WARRANTY PERIOD begins with the retail sale and set-up of the motorcycle by one of our authorized Triumph Motorcycle dealers and ends 180 days after sale or when the motorcycle has been ridden 6,000 miles, whichever occurs first. However, in the case of appearance items with painted or plated finishes, the warranty is limited to 30 days from the retail sale.

IN ORDER TO QUALIFY FOR THIS WARRANTY:

- 1) It is essential that an Owner's Warranty Registration Card be filled out at the time of purchase and mailed immediately to Triumph Motorcycles America.
- 2) You must operate and maintain the motorcycle as specified in the Owner's Handbook.
- 3) You must take your Triumph Motorcycle to an authorized Triumph dealer after it has been ridden 500 miles or within 90 days of purchase, whichever comes first, for a service check. The Free Service Coupon is in the back of your Owner's Handbook. The service check is free of charge, except for charges for oils, grease, and replacement of any items necessitated by normal wear.

EXCLUSIONS: This warranty does not extend to parts affected or damaged by accident, fire, exposure, neglect, unreasonable use or abuse; replacement of "normal wear" items such as spark plugs, ignition points, light bulbs, clutch plates, drive chains, brake linings, hand grips, peg rubbers, kickstart and footshift rubbers, and oil; or ignition timing accuracy and carburetor settings after the 500 mile service has been completed, or any motorcycle on which the odometer mileage has been

altered so that correct mileage cannot be determined. **ALSO EXCLUDED** are use of the motorcycle for racing, competition or rental, the incorporation of or use of accessories or replacement parts not approved by Triumph, or the unauthorized alteration of any part, *and the purchaser is warned that such use, attachment or alteration voids this warranty.*

HOW TO OBTAIN WARRANTY REPAIRS: Take your Triumph Motorcycle with your Customer Identification Card or other proof of date of purchase, at your expense, to any authorized Triumph Motorcycle dealer in the United States or Puerto Rico during his normal business hours. All defective parts replaced under this warranty become the property of Triumph Motorcycles America Inc.

If you are unable to obtain warranty repairs, or are dissatisfied with the quality of work done for you on the 500-mile service check or any warranty service, ask to discuss the matter with the service manager or owner at the dealership. If you still feel you need help or do not obtain satisfaction, write to the Service Department, Triumph Motorcycles America Inc., P.O. Box 1060, Placentia, CA 92670.

WARNING: Modification or alteration of the motorcycle by the selling dealer or by any other person may make the motorcycle unsafe even under normal use. Any modification of the frame, steering mechanism, suspension system, or wheels may alter the steering and handling characteristics of the motorcycle and may create a serious risk of grave injury. **TRIUMPH CANNOT BE RESPONSIBLE FOR ANY SUCH INJURIES, EITHER UNDER THE WARRANTY OR OTHERWISE.**

IMPLIED WARRANTIES: Under the law, the owner is entitled to the benefit of the implied warranties. **THESE IMPLIED WARRANTIES WILL CONTINUE IN FORCE ONLY DURING THE WARRANTY PERIOD.** Some states do not allow limitations on how long implied warranties last, so this limitation may not be applicable in your case.

INCIDENTAL OR CONSEQUENTIAL DAMAGES: Neither Triumph Motorcycles America nor the dealer who sold this motorcycle has any responsibility for any consequential damage or commercial loss to the owner, or for any incidental expenses, such as loss of time or towing or transportation charges. Again, however, some states do not permit the limitation of incidental or consequential damages, so this may not apply in your case.

OTHER LEGAL RIGHTS: In addition to the specific legal rights conferred on you by this warranty, you may have other and additional rights which vary from state to state.
